1. This report includes 10 models of Lithium Iron Phosphate Battery Energy Storage System: Optim US-A1-M7-A-125/522-EU-xx, Optim US-A1-M7-A-124/522-EU-xx (where xx=01, 02, 03, 04, or 05), 'xx' represents the selection of fire and explosion safety configurations, as follows:

01: explosion relief panel;

02: explosion relief panel and water fire protection;

03: explosion ventilation system (combustible gas detector + explosion-proof ventilation fan);

04: explosion ventilation system (combustible gas detector + explosion-proof ventilation fan) and water fire protection;

05: explosion ventilation system (combustible gas detector + explosion-proof ventilation fan), water fire protection and explosion relief panel.

According to the manufacturer's declaration, all the models are similar in hardware, except for the differences mentioned above, the different rated power adjusted via software. Therefore, the model Optim US-A1-M7-A-125/522-EU-05 was chosen to perform the EMC tests as representative. The test configuration was specified by the manufacturer. 4 Immunity Performance Criteria

The performance criterion to be used during test is detailed below:

4.1 Performance Criteria of EN IEC 61000-6-2

The performance criterion for the immunity tests in clause 4 of EN IEC 61000-6-2:2019 are listed as follows:

Performance criterion A

The EUT shall continue to operate as intended during and after the test. No degradation of performance or loss of function is allowed below a performance level specified by the manufacturer, when the EUT is used as intended. If the performance level is not specified by the manufacturer, this may be derived from the product description and documentation and what the user may reasonably expect from the equipment if used as intended.

Performance criterion B

The EUT shall continue to operate as intended after the test. No degradation of performance or loss of function is allowed below a performance level specified by the manufacturer, when the EUT is used as intended. The performance level may be replaced by a permissible loss of performance. However, during the test degradation of performance is allowed but no change of actual operating state or stored data is allowed. If the minimum performance level or the permissible performance loss is not specified by the manufacturer, either of these may be derived from the product description and documentation and what the user may reasonably expect from the equipment if used as intended.

Performance criterion C

Temporary loss of function is allowed during the test, provided the function is self-recoverable or can be restored by the operation of the controls.

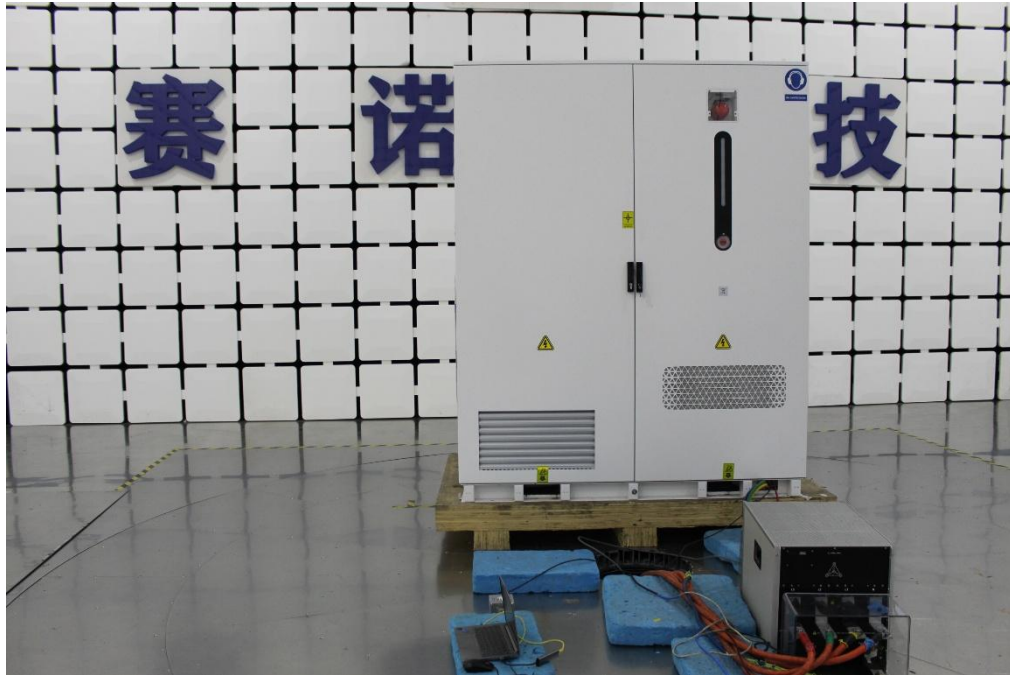

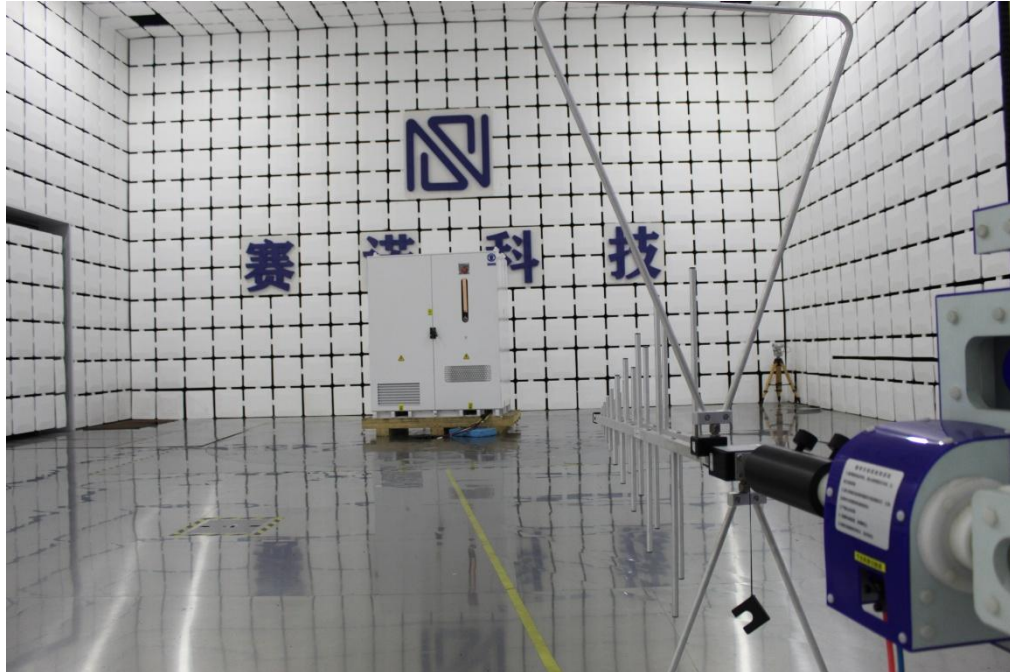

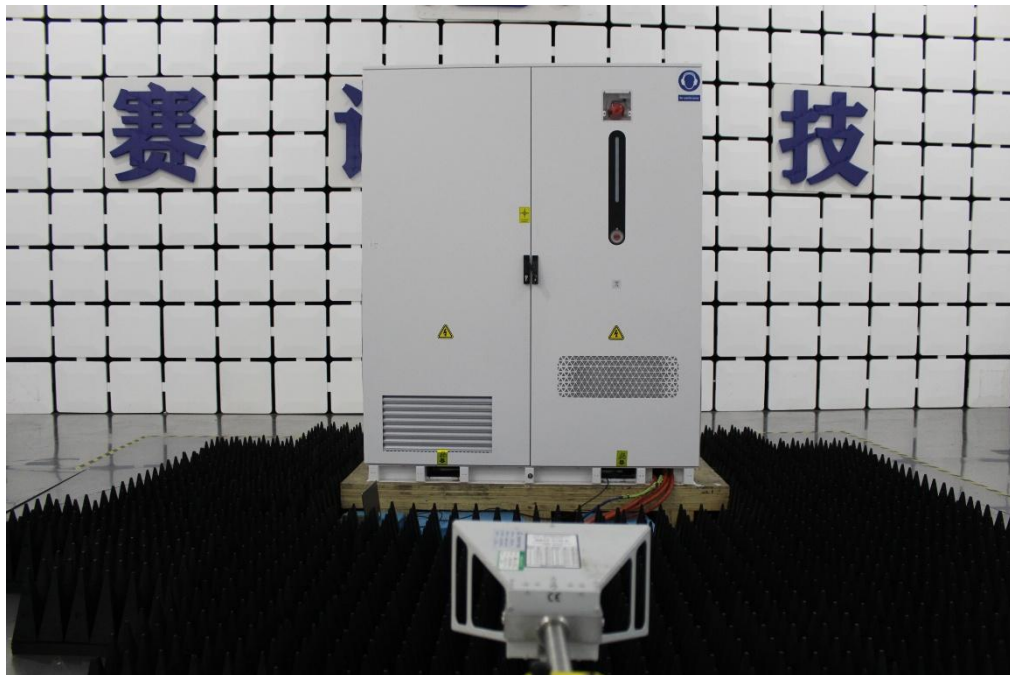


(Wired network port)

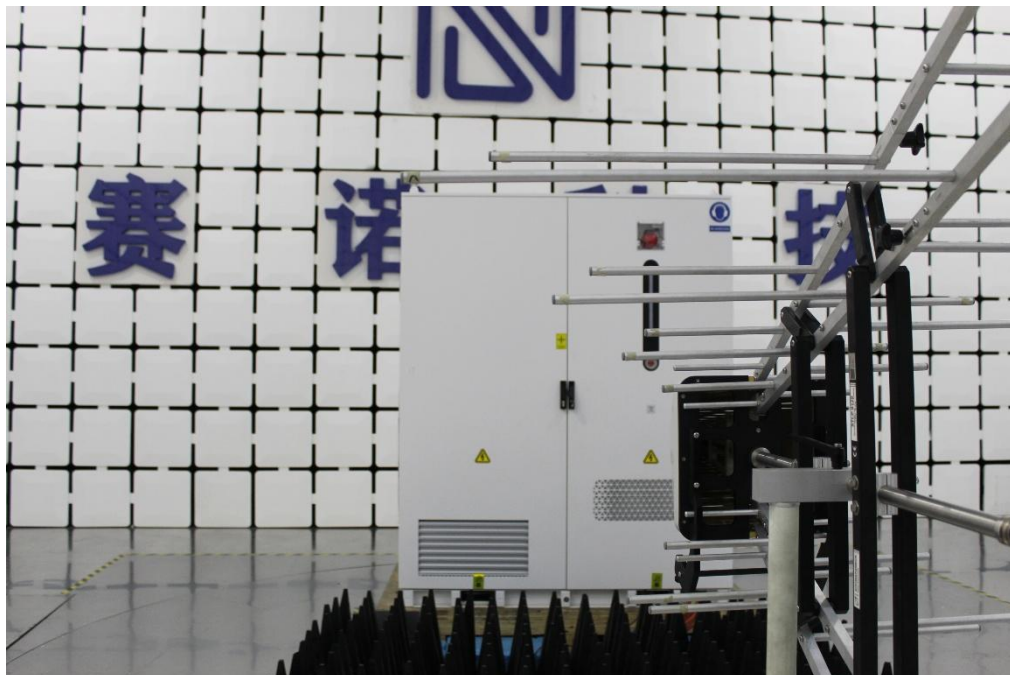

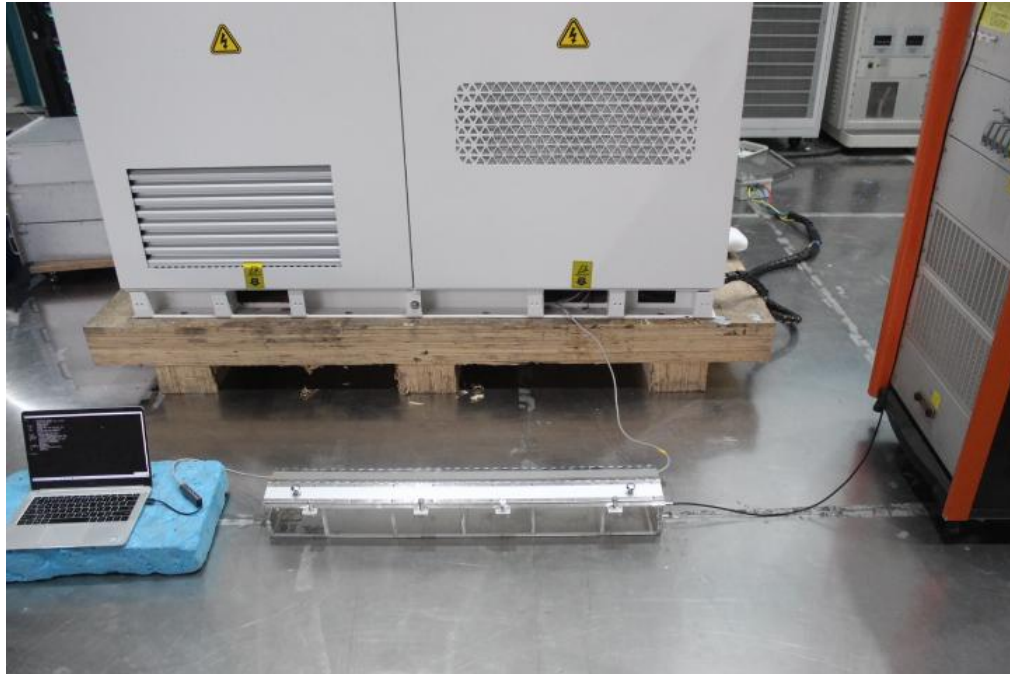

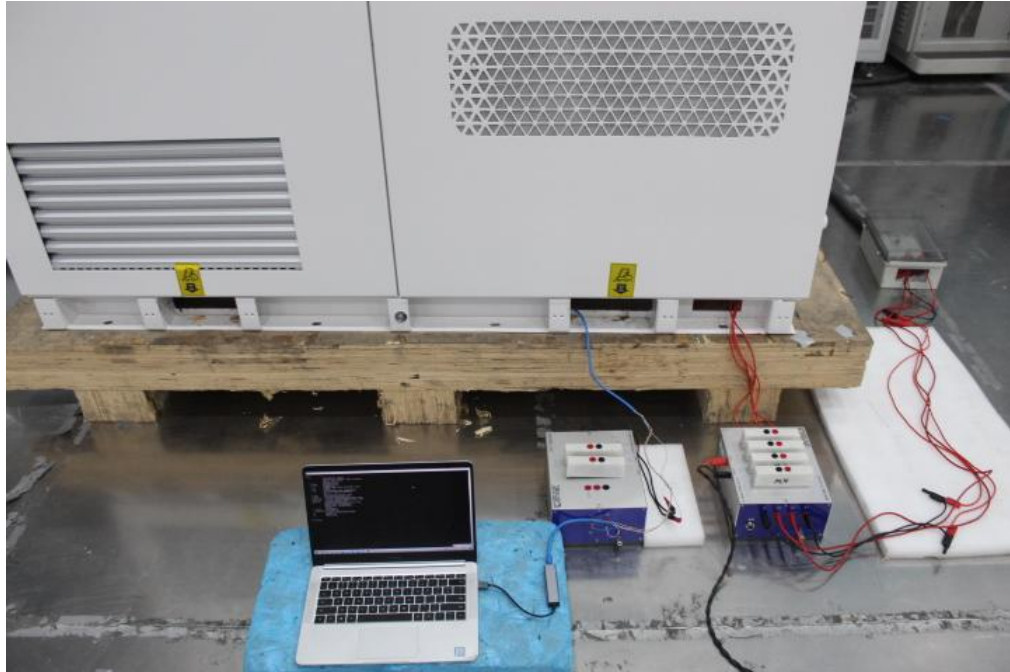
